To the tender process of the project: "Production of fiber cement boards"

TENDER'S OBJECT: Creation of a Mixed Company to install a new factory of a fiber-cementbased board system and the constructive system associated with it, that can be used both indoorsand outdoors, with the fundamental purpose of substituting the imports in the boards with bindersofcement,called"CEMENBOARD".It is proposed the introduction of a technology that allows the production of asbestos-free fiber-cement boards, with a production capacity of around 5 million m². It will install a leading-edgetechnology with possible applications of nanotechnology and the use of renewable energysources, which complies with the environmental regulations existing in the country.The new factory would be placed inside of Fiber cement Perdurit Company (UEB Artemisa),located in Finca Santa Teresa, Las Cañas, Province of Artemisa, approximately 31 km (40minutes) from the Mariel Industrial Development Zone (ZDIM).

<u>Place and date of delivery of the bids:</u> They will be delivered to the headquarters of the Fiber cement Perdurit Company, located on A Street number 829 between 35 and Carlos Manuel de Céspedes, Plaza de la Revolución, Havana, Cuba, with a deadline of March 9, 2018.

Tender's specific conditions:

- The foreign bidder will comply with the provisions of the previously specified schedule.
- Explicitly provide legal documentation that allows proper identification:
- a) Copy of the constituent document legalized to have effects in Cuba and protocolized before a Cuban notary.
- b) Certification of the mercantile registry or similar of its country of origin that proves its validity, with no more than six (6) months of issue and with its corresponding translation to the Spanish language where appropriate, legalized before the corresponding Cuban consulate or embassy and protocolized before Cuban notary.
- c) Powers of presentation legalized to have effects in Cuba and protocolized before a Cuban notary in the case of being a legal entity the foreign investor.





- d) Photocopies of passport of the representative or representatives to process the permits with their corresponding visa D * 7.
- e) Accreditation of their experience in the activity object of the foreign investment and their capacity to manage the export markets of goods and services as appropriate.
 - Deliver technological proposal to be used to fulfill the purpose of this tender, taking into account:
- a) The capacity of this to achieve the necessary quantities and quality of the productions to be marketed.
- b) Cost of equipment.
- c) Variants that ensure an economically more efficient energy exploitation of the equipment.
- d) Variants of fuel types to be used.
- e) Possible uses of alternative energy.
- f) Strategies aimed at the sustainability of the equipment to be installed, with a maintenance budget.
- g) Proposed treatment, management and final destination of the waste.

For the clarification of all the technical details there will be a technical meeting with the foreign bidder where all the doubts will be clarified in order that a suitable offer can be presented to the real needs of the project.
